24 Idaho Code § 25-3502 (12) draft verbiage reads as follows:

25
26 “Medical care” means the care given to animals to improve their quality of
27 life or care for physical medical needs. Such care is not required to be
28 provided by a veterinarian and may be provided by an owner or an owner’s
29 designee.
