Dr. Maupin moved to exit executive session at 4:05 PM. Dr. Dredge seconded the motion. Motion passed.

Dr. Dredge moved to conditionally deny a license to practice veterinary medicine in Idaho to applicant no. V-4675 until applicant passes the North American Veterinary Licensing Examination (NAVLE) and the Clinical Proficiency Examination (CPE) available through the American Veterinary Medical Association (AVMA). These exams will allow the Board to evaluate the professional competence of the applicant. Dr. Maupin seconded the motion, which passed unanimously.

While in Executive Session staff and Board General Legal Counsel discussed with the Board the apparent settlement of litigation in Ada County Case No. CV01-16-20844 as well as records exempt from public disclosure because they are records obtained or generated in connection with a Board disciplinary contested case proceeding. 




